It was moved by Thomas, seconded by Michael to accept the consent agenda which consisted of minutes from the last regular meeting on 5/4/20, bills paid 5/5/20 thru 5/15/20, and bills to be paid 5/18/20. Roll call vote all ayes. Motion carried.

It was moved by Haughey, seconded by Michael to pay Snyder and Associates \$53,497.55 for levee engineering and to transfer money from the reserve to cover the expense. Roll call vote all ayes. Motion carried.

It was moved by Beatty, seconded by Thomas to pay the Tama County Highway Department \$9,939.92 for repairs to the Deer Creek Bridge and to transfer money from the reserve to cover the expense. Roll call vote all ayes. Motion carried.

The Mayor will inform the owner of 1201 Harding St to have his property surveyed to make sure his property lines are correct.

After some discussion the Council decided not to make a donation towards the STC Tennis Courts at this time.

The City Clerk informed the Council of the requests presented to Iowa Premium for a potential donation.

Don Weitzell, Tama Paramedic presented information to the Council in regards to hiring 2 part time Advanced EMT's or Paramedics. He would like to hire 2 part time positions to fill in the weekends where he struggles to get volunteers to fill in the schedule. The Council directed Don to work towards a job description to present to the Council prior to advertising.

There were no updates on Library repairs at this time.

The City Attorney has prepared documents for the donation of Duane Pansegraus property on 14th St. The Mayor will review the documents and present them to Pansegrau prior to our next regular meeting.

The Council discussed nuisances' houses. The Council will work towards creating a list of homes to send letters to. Michael would like to check into cameras at the recycling area due to people leaving non-recyclable items and trash in the area.

It was moved by Michael, seconded by Haughey to approve Resolution No. 11-20, a resolution approving the Tama-Toledo News Chronical as the official publication for the City of Tama. Roll call vote ayes: Babinat, Thomas, Beatty, Michael, Haughey. Motion carried.

It was moved by Beatty, seconded by Haughey to approve Resolution No. 12-20 a resolution setting the FY20 Budget Amendment public hearing for June 1, 2020 at 5:30. Roll call vote ayes: Michael, Haughey, Babinat, Beatty, Thomas. Motion carried.

Reports: Thomas: Met with the neighbors on 9th Street to continue to make a plan for curb and gutter on the street.

Haughey- Would like to work towards giving the PD a clear understanding of the specific nuisance issues to work on.

Mayor Ray- Would like to see the lake get cleaned up. Possibly getting volunteers together to work on it.
