The Council discussed the use of the 2016 Chevy truck. The Council would like to see the Water Department take the truck and work through adjusting numbers during the budget.

The Council considered the rates from Lincoln Savings Bank, Pinnacle Bank, and State Bank of Toledo. It was moved by Haughey, seconded by Babinat to invest the million-dollar CD to a 12-month CD at Lincoln Savings Bank at a rate of 1.85%. Roll call vote all ayes. Motion carried.

It was moved by Haughey, seconded by Thomas to approve removing Mike Carnahan and Robert Tyynismaa from the bank accounts and to add Doug Ray and Emily Babinat to the accounts as authorized signers. Roll call vote all ayes. Motion carried.

It was moved by Babinat, seconded by Thomas to approve Resolution No. 1-20 a resolution changing the time of the regular Council meeting to 5:30 PM. Roll call vote all ayes. Motion carried.

It was moved by Haughey, seconded by Babinat to set a budget meeting for January 13, 2020 at 5:00 PM. Roll call vote all ayes. Motion carried.

It was moved by Babinat, seconded by Haughey to set the Max Levy Public hearing to February 3, 2020 at 5:30 PM. Roll call vote all ayes. Motion carried.

Reports: Babinat- Community Foundation is open until the 15th for grant applications.
Mayor Ray- Would like to focus on parking tickets and nuisance properties.
