It was moved by Haughey, seconded by Tyynismaa to approve Resolution No. 25-19 a resolution approving an interloan of \$20,340.00 for the Downtown Improvements in the Urban Renewal Tax Increment Area No. 1 and to certify the same amount to the Tama County Auditor for collection from Tax Increment Revenue. Roll call vote ayes: Ray, Tyynismaa, Babinat, McAdoo, Haughey. Motion carried.

The levee contract/grant update until the next meeting on November 18, 2019.

The City Clerk updated the Council on the possibility of fuel tanks from New Century FS. At this point details are still being worked out as we are unable to have fuel tanks within 500 ft of any wells.

The City Clerk also informed the Council of efforts to retain new phones for City Hall through Verizon. We will not be able to utilize Verizon at this point due to a contract with Mediacom.

John Lloyd, Public Works Director informed the Council that certified letters have been sent to 10 properties they have until November 21, 2019 to respond and clean up the property before the City will perform the necessary clean up.

The Mayor reminded the Council of the upcoming Census and would like to work towards building a census planning committee with the City of Toledo.
