September 3, 2019

The regular meeting for the Tama City Council met Tuesday September 3, 2019 at 6:00 PM in the Tama City Council Chambers. Mayor Carnahan called the meeting to order with the following council member answering to roll call: Haughey, Tyynismaa, Babinat. Absent: McAdoo and Ray. Visitors: Larry Thomas, Don Weitzell, Tim Bradley, Jeff Large, John Lloyd Lindsey and Parker Just with Snyder and Associates.

It was moved by Babinat, seconded by Haughey to approve the consent agenda which consisted of minutes from the last regular meeting on 8/19/19, bills paid 8/20/19 thru 8/30/19, bills to be paid 9/3/19 including Tama County Economic Development for \$5,754.00, Ed Hardon for Façade at 110,112, and 114 W 4th St for a total of \$9,737.74. Liquor License renewal for Jiffy South and Liquor License renewal for Tama-Toledo Country Club. Roll call vote4 all ayes. Motion carried.

This being the time and place, Mayor Carnahan opened the public hearing for the FY 20 Budget Amendment. There being no oral or written comments the Mayor closed the public hearing. It was moved by Haughey, seconded by Tyynismaa to approve Resolution No. 17-19 approving the FY 20 budget amendment as presented. Roll call vote ayes: Haughey, Babinat, Tyynismaa. Motion carried.

Lindsey and Parker with Snyder and Associates presented the levee screening to the Council. The Council discussed the pros and cons of accrediting the levee with FEMA. The Council will continue to consider the route to take in regards to the Levee Accreditation.

A motion was made by Babinat, seconded by Haughey to approve and accept offer of Tim Bradley in the amount of \$10.00 subject to compliance with applicable legal requirements and procedures. Roll call vote all ayes. Motion carried.

Larry Thomas with the Ambulance Department addressed the Council with the possibility to raise the trust contribution to \$75.00. Council member Babinat requested that we address this when we begin budget meetings for FY21.

It was moved by Babinat, seconded by Tyynismaa to approve the expense from the Ambulance trust account for a training mannequin and ventilators, both of which the department has received grants for. The total remaining expense which exceeds the grant amounts is \$10,097.40. Roll call vote all ayes. Motion carried.

It was moved by Tyynismaa, seconded by Babinat to approve Larry Werner for the Fire Department. Roll call vote all ayes. Motion carried.

It was moved by Babinat, seconded by Haughey to approve Resolution No. 18-19 a resolution approving the community development block grant at 808 Siegel St. Roll call vote all ayes. Motion carried.

The Mayor and Council discussed the new employee handbook. They would like to see a paragraph added to address secondary employment. The City Clerk will add a section and send it to the Council prior to the next regular meeting.

The Mayor and Council discussed lifting the burn ban, but chose to keep it for the time being. They will consider lifting it at a later date.

Reports: Babinat- Attended the Library Board meeting. They would like to have the City take the lead on repairing the building. They also will consider working on winter hours to accommodate citizens.

Mayor Carnahan- The Council will meet Monday September 9 at 7:30 to look at the water tank.
