The regular meeting for the Tama City Council met Monday March 18, 2019 at 6:00 PM in the Tama City Council Chambers. Mayor Pro-Tem Tyynismaa called the meeting to order with the following council member answering to roll call: McAdoo, Ray, Haughey, Tyynismaa. Absent: Mayor Carnahan and Babinat. It was moved by Ray, seconded by Haughey to approve the consent agenda which consists of minutes from the last regular meeting on 3/4/19, bills paid 3/5/19 thru 3/15/19, and bills to be paid 3/18/19. Roll call vote all ayes. Motion carried.

A motion was made by McAdoo, seconded by Haughey to approve the third and final reading of Ordinance No. 587 a storm water utility ordinance to take affect as of the July 2019 billing. Roll call vote ayes: Haughey, Ray, Tyynismaa, McAdoo. Motion carried.

Amanda Accola with Alliant Energy addressed the Council about the upcoming Franchise Agreement renewal. The Council will discuss the options and look into renewing the Gas Agreement at the same time.

It was moved by Ray, seconded by Haughey to approve Cooper Coffman's resignation from the police department. The Council thanked Coffman for his time with the City. Roll call vote all ayes. Motion carried.

Chief Bina presented the Council with a request to use forfeiture money towards gym memberships at Flex Fitness for all the full-time officers who are interested in utilizing the gym. A motion was made by McAdoo and seconded by Tyynismaa to authorize the Police Department to use forfeiture money until forfeiture money is depleted for gym memberships for the full-time officers. Roll call vote all ayes. Motion carried.

The Council along with Chief Bina discussed the possibility of changing the parking ordinance for downtown to allow parking 24 hours. The City Attorney will present the Council with a possible Ordinance at the next Council meeting.

The Council discussed the options of adding UTV's along with the golf cart ordinance. The Council and citizens had many ideas and it was decided to get a couple council members together to discuss some possible options and present that to the Council at a later meeting.

It was moved by McAdoo, seconded by Haughey to approve the purchase of a Ringomatic 550VX Dual Jetter with the cost of \$83,870 to be split with the City of Toledo. Tama's cost being \$41,935 to be split between the water, waste water, and street departments. Roll call vote all ayes. Motion carried.

It was moved by Haughey, seconded by Tyynismaa to approve the payment of \$4,820 to Region 6 Planning Commission contingent on the reimbursement from the CDBG housing program. Roll call vote all ayes. Motion carried.

Reports: Ray- Would like to continue to work on the beautification project and possibly get a work session set up to get started.
