

December 17, 2018

The regular meeting for the Tama City Council met Monday December 17, 2018 at 6:00 PM in the Tama City Council Chambers. Mayor Carnahan called the meeting to order with the following council member answering to roll call: McAdoo, Haughey, Ray, Tyynismaa, Babinat. Visitors: John Lloyd, Jason Bina, Ashley Aylsworth, and Chris Smith.

It was moved by Ray, seconded by McAdoo to approve the consent agenda which consisted of minutes from the joint council meeting on 11/26/18, minutes from the last regular meeting on 12/3/18, bills paid 12/4/18 thru 12/14/18, bills to be paid 12/17/18, refund liquor license to Las Dos Fuentes, and approve the liquor license for the Tama Ballroom. Roll call vote all ayes. Motion carried.

Discussion on the potential school resource officer has been tabled until a later date.

It was moved by Babinat, seconded by Ray to approve the hiring of David Schulze with TSP as the Architect for repairs and maintenance to the Tama Public Library. Roll call vote all ayes. Motion carried.

Ashley Aylsworth updated the Council on the status of her new business. Aylsworth will need the City to be a second lien holder on her loan with the City. Aylsworth plans to open by February 1, 2019.

It was moved by Tyynismaa, seconded by Haughey to approve the final pay request to Vieth Construction in the amount of \$29,660.22 for the 5th Street Project. Roll call vote all ayes. Motion carried.

It was moved by McAdoo, seconded by Ray to approve the purchase of the Laserfiche software with Advanced Systems. This project will be budgeted for in FY20 in the amount of \$4,780.00. Roll call vote all ayes. Motion carried.

It was moved by Haughey, seconded by Babinat to approve the payment to ILEA in the amount of \$6,240.00 for Officer Kessler's tuition. Roll call vote all ayes. Motion carried.

The dates for budget workshops were set for January 7th, 14th, 21st and 28th at 6:00 PM.

It was moved by Babinat, seconded by Ray to approve the purchase of new counter tops for the auditorium in the amount of \$1,995.00 from Hrabak Lumber Company. Roll call vote all ayes. Motion carried.

Reports: John Lloyd informed the council that the fence line by the cemetery has been cleaned out. The pump at the lift station has been repaired. The high service pump #3 at the water plant has been refurbished and is back in service.

Haughey: He has had a request that the City look into doing a walking trail on 9th Street, the gravel road leading to the cemetery.

Ray: He discussed the parking on 3rd and 4th Street, in the downtown area during the winter. Do we need to put a snow ordinance into effect for these areas. John Lloyd feels that we should leave it as is.

Babinat: Reported that the Library Board is concerned about the cost of the repairs needed for the building.

Mayor: He is looking for volunteers to paint in the Civic Center during Christmas break.

A motion was made by Babinat, seconded by Tyynismaa to adjourn at 6:55 PM.
