The Council discussed the grants that were received from The Community Foundation. The Police Department received \$2,500.00 for a laptop, Public Works received \$2,000.00 for a drone, and the Civic Center received \$3,000.00 for a lit sign.

Citizen Reports: Jim Pansegrau- wanted to make the Council aware of fireworks in the City limits. He noted there has been quite a bit of debris on houses and in yards.

Mike Haughey- wanted to thank the Police Department and recognize them for all their hard work.
