The regular meeting of the Tama City Council was held September 4, 2018 at 6:00 PM. Mayor Carnahan called the meeting to order with the following Council Members answering to roll call: McAdoo, Haughey, Ray, Tyynismaa, Babinat. Visitors: Mark Currie, Kellie Scott, Tim Wallace, and numerous other visitors.

Mark Currie with Shuck-Britson Inc. presented the Council with his projected engineering costs for the Lincoln Highway Bridge. Mark explained that the project will require a little more supervision from the engineers to insure everything is properly handled. He made the Council aware that the projected longevity of the repaired bridge will be 10-15 years. The Council directed Mark to prepare a contract to be presented at the next regular City Council Meeting.

It was moved by Haughey, seconded by Babinat to approve pay request No. 7 to Horsfield Construction in the amount of \$12,582.34. Roll call vote all ayes. Motion carried.

Discussion on the possibility of selling the Sugar Shack property has been tabled until further notice.

Babinat reviewed the 28E agreement with Tama County Economic Development, the contract is locked in until February of 2019. The Council will readdress if they are satisfied with the improvements. It was moved by Babinat, seconded by Haughey to approve the dues in the amount of \$5,754.00. Roll call vote all ayes. Motion carried.

It was moved by Babinat, seconded by McAdoo to approve the purchase of a plasma cutter in the amount of \$1,971.22 from Airgas. Roll call vote all ayes. Motion carried.

It was moved by Haughey, seconded by Babinat to approve Bargen Inc. to do up to 10 infrared patches at \$305.00 per patch. Patching to be performed on the Civic Center parking lot. Roll call vote ally ayes. Motion carried. It was moved by Babinat, seconded by Haughey to approve John Lloyd to attend the Iowa Rural Water Training in Dubuque to finish his CEU's for the year. Roll call vote all ayes. Motion carried.

A motion was made by McAdoo, seconded by Haughey to approve Resolution No. 13-18 a resolution setting the public hearing for the adoption of the proposed Code or Ordinances for the City of Tama for October 1, 2018 at 6:00 PM. Roll call vote ayes: Haughey, Babinat, McAdoo. Motion carried.

Reports: McAdoo- Wants to make sure we discuss the nuisance properties at the next meeting.

Mayor Carnahan- Reminds everyone of the Car Show on September 15, 2018. We will also discuss the Haunted Hayrack Ride in the near future.
