The regular meeting of the Tama City Council met April 2, 2018 in the Tama Council Chamber at 6:00 PM. Mayor Carnahan called the meeting to order with the following Council Members answering roll call: Babinat, Haughey, Ray, Tynismaa, McAdoo. Visitors: Amelia Kemper, Deb Hanus, Brian Sokol, Don Vorwald, Ed Hardon, John Lloyd.

It was moved by Ray, seconded by Babinat to approve the consent agenda which included minutes from the last meeting on 3/19/18 and bills to be paid 4/2/18. Roll call vote all ayes. Motion carried.

Brian Sokol with Kids Corner Day Care Board approached the Council about the possibility of a donation. The Council agreed they are in favor of making a donation and will discuss and have a decision in an upcoming meeting.

Ed Hardon presented the council with bids to upgrade the street light meters for 3rd and 4th street in the amount of \$5,990.00 at 137 W 3rd St and \$4,975.00 at 103 E 3rd St. Alliant Energy has been in contact with Ed about upgrading the meters for more accurate readings. The Council made no motion at this time.

The Mayor present the following lawn mowing bids:

For the Aquatic Center - Don Vorwald \$100.00 first time clean up then \$115.00 for every mow.

- Tom Kemper Mowing \$95.00 per mow
- TLC \$130.00 per mow

Citizen Mowing- Danny Schuett \$30.00 per yard as needed.

It was moved by Babinat, seconded by Ray to accept Tom Kemper's bid for the Aquatic center contingent on providing proof of liability insurance. Roll call vote all ayes. Motion carried.

It was moved by Haughey, seconded by Tynismaa to approve Danny Schuett's bid for citizen mowing. Roll call vote all ayes. Motion carried.

It was moved by Tynismaa, seconded by Haughey to approve Resolution No. 3-18 a resolution to approve the City of Tama Community Development block grant owner occupied housing rehabilitation contract for 504 Hall St. Tama, IA 52339. Roll call votes: McAdoo, Babinat, Haughey, Ray, Tynismaa. Motion carried.

The Mayor and McAdoo decided to discuss the Haunted Hayrack ride at the next Council meeting.

It was moved by Ray, seconded by Tyynismaa to approve Alyssa to go to IMFOA in Des Moines April 18-20. Roll call vote all ayes. Motion carried.

Reports: Haughey- Was approached by a few citizens about setting up or opening a paintball park near the ATV park.

McAdoo- Would like to check into a key fob/time clock system for security and accurate tracking of time for employees.

John Lloyd- 5th Street construction will continue as soon as the weather gets warmer. It was moved by Haughey, seconded by Babinat to allow John Lloyd, Public Works Director to contact S.O.S. to arrange for rehab of manhole at 10th Street and McClellan Street and up to two additional manholes at a total cost not to exceed \$7,500.00. Roll call vote all ayes. Motion carried.

Mayor Carnahan- Would like to see that the Council takes the time to review the handbook and have a work session on May 7th at 5:00 PM.
