Roll call vote all ayes. Motion carried.

It was moved by Beatty, seconded by Haughey to approve Edge Performance to complete wraps on the Iowa Economic Development Grant trailers in the amount of \$2,800.00. Roll call vote all ayes. Motion carried.

It was moved by Haughey, seconded by Michael to approve setting the public hearing for the FY22 Budget for March 1, 2021 at 5:30 PM. Roll call vote all ayes. Motion carried.

The Council and Street Superintendent discussed the ice build up on the streets and curbs.

The Council discussed nuisance snow removal. Suggestions were to take before and after pictures, along with discussing with the PD to give citations for violations.

The Council tabled discussion of the stump removal approach for the Spring of 2021.

It was moved by Michael, seconded by Haughey to approve the purchase of a replacement seat for the loader in the amount of \$1,472.00 Martin Equipment. Roll call vote all ayes. Motion carried.

The Council discussed the wiring at the lights on the North side of the City Park. The Council recommends checking into repairing the wiring rather than removing poles.

It was moved by Michael, seconded by Babinat to approve Resolution No. 6-21 a resolution approving the Tama-Toledo Aquatic Center amended and substituted 28E Agreement and increase to the annual aquatic center appropriation dated January 26, 2021 and rescinding Resolution No 3-21. Roll call vote ayes: Beatty, Haughey, Babinat, Michael. Motion carried.

It was moved by Babinat, seconded by Haughey to accept the resignation of Mindy Benson in her roll as Tama Landfill Committee representative. Roll call vote all ayes. Motion carried.

It was moved by Haughey, seconded by Babinat to appoint Larry Thomas to the Tama County Landfill Committee representative. Roll call vote all ayes. Motion carried.

Visitor: Morgan Haughey, President of STC Student Council and NHS Vice President presented to the Council a project being worked on called Trojan Way Clean Up Day, where students plan to volunteer around the community to gain volunteer hours. The Council is appreciative of the efforts from STC students and looks forward to hearing more of their success in the project.

Reports: Michael- informed the Council of the Library Boards plans to work on updating the thermostat and furnace.
